LEGENDARY CELLIST PABLO CASALS WAS AMONG ITS FOUNDERS, AND JAZZ LEGEND CAB CALLOWAY ONCE SERVED ON ITS BOARD. MCW'S MISSION IS TO PROVIDE THE EXTRAORDINARY BENEFITS OF MUSIC TO ALL IN OUR COMMUNITY.
