HEALING OUR HEROES HAS BEEN RECOGNIZED AND SUPPORTED BY DISABLED AMERICAN VETERANS, AND IS FEATURED IN MUSIC VETS, A RECENTLY RELEASED DOCUMENTARY FILM ABOUT THE CHALLENGES FACED BY VETERANS DEALING WITH THE WOUNDS OF WAR AS THEY STRUGGLE TO READJUST TO CIVILIAN LIFE. MUSIC VETS WAS PREMIERED AT THE KENNEDY CENTER IN OCTOBER, 2023 AND HAS HAD SCREENINGS AT THE BEDFORD PLAYHOUSE, NEW YORK UNIVERSITY AND OTHER LOCATIONS.
